




table in the back of the sanctuary or the church office.

St. James Council Meeting Minutes - September 10, 2025

Meeting was called to order at 5:35 p.m. by Jim Davies. Present: Amanda Wehrhan, Robin Lursen, Leslie Groen, John Endelman, Ted Koester, Andrew Morton, Kiley Shear, Aimee Duell, Alyssa Endelman, Mindy Pecha, Randy Brinkman and Pastor Rebecca Baird. Devotions given by Pastor Rebecca. All ayes. Motion carried. Motioned by Aimee, second by Alyssa to approve the agenda. All ayes. Motion carried.

REPORTS:

Treasurer's Report: August income was \$14,938.93. August expenses totaled \$13,496.61. Motion by Ted, second by Robin to approve the Treasurer's report. All ayes. Motion carried.

Secretary's Report: Motioned by Pastor Rebecca to approve the August 13, 2025, minutes with edits, second by Kiley. All ayes. Motion carried.

Motioned by Pastor Rebecca to approve the September 3, 2025, minutes with edits, second by Aimee. All ayes. Motion carried.

Property Committee: See old business for quotes on ADA items

Education/Youth Ministry: Amanda shared they will be purchasing baskets and bins to place toys throughout the sanctuary. In addition, they would like to update the nursery by removing the unsafe crib, adding small furniture and painting. Motioned by Amanda, second by Alyssa to approve painting a mural in the nursery to be completed by Aimee Duell this fall. Alyssa suggested utilizing unused Sunday School funds to cover the costs of materials, toys, etc.

Memorial Committee: The ADA items will be purchased with Memorial Funds.

Worship & Music: Recently met and made service selections.

Pastor Rebecca's Report: This past month Pastor has been completing general housekeeping of administrative tasks and goodbyes since announcing her resignation. She has also been preparing the conclusion of call liturgy for the Sept. 28th service. Pastor Rebecca mentioned the funeral for Pat Feltus on August 27th, she officiated Madison Klingenborg's wedding on September 6th and will be officiating Michaela Shear's wedding on September 20th.

Old Business:

Randy provided information related to ADA items including a replacement lift and push button handicap door. The ADA compliance updates will be purchased with Memorial Funds. Ted explained the council could approve the handicap door because it is under the purchase threshold, but the new lift is over and

requires a congregational vote. Dates were discussed told hod a congregational vote for the combined ADA items. Motion by Kiley, second by Ted to set October 5th for the congregational vote. All ayes. Motion carried

Ted will create a sign-up sheet for worship duties to be reviewed next month.

New Business:

Microphones – Jay Doeden has offered to fund new microphones and offered written suggestions. Alyssa will reach out to Jay for additional suggestions and vendors for getting quotes.

Roof Committee – There will be a roof dedication on the September 21st and the committee would like to wrap-up even though the goal has not been met. Council discussed options to continue offering and accepting roof donations in the future to reach the goal. Motion by Kiley to dissolve the roof committee following the September 21st dedication, second by Andrew. All ayes. Motion carried.

Pastor Rebecca and Jim discussed the use of a Transition team consisting of a group of 5 to 6 individuals to assist with pulpit supply, congregational worship helps, funerals, hospital visits, Sunday School, etc. Pastor Rebecca suggested reaching out to individuals with leadership roles on committees to help. She also mentioned Steve Bracket will talk to Council about this next month.

Jim read through constitution and found that offering counters should not be an officer in the church; therefore, Ted cannot be both a counter and Vice President. Amanda has volunteered to take over as Vice President. Motion by Andrew, second by Kiley to replace Ted with Amanda as Vice President of Church Council. All ayes. Motion carried. Jim also shared concerns with Pastor Rebecca leaving and needing help and support to get through the months ahead.

Pastor Rebecca asked for six readers during the conclusion of call liturgy service on Sept 28th – Need to have reading parts.

Amanda, Robin, Aimee (including Carter and Ava) and Kiley volunteered.

Church Council held an exit interview with Pastor Rebecca. She provided an insightful prospective for St James to utilize during the call process.

Motioned to adjourn made by Andrew, second by Aimee. Meeting adjourned at 7:03 p.m. Next meeting will be held October 10th at 5:30 p.m.

Congregational Meeting for Chair Lift and ADA Door Opener

October 5, 2025

The meeting was called to order at 10:30 am by Council President Jim Davies. Randy Brinkman from the presented the quotes and recommendations from the Property Committee. The quotes up for approval are as follows:

Lift – Access Elevator & Lifts Inc, Des Moines: \$46,450.00; if we take the old lift out, they will deduct \$1,000, bringing the total to \$45,450.00. We can dispose of the old lift in the metal recycle bin by the school bus barn. There is only one quote for this as Access is the only one in our region that works in Iowa.

ADA Door Opener

1. Walsh Door & Security, Des Moines: \$5,125.00 installed less electrical work

2. DH Pace, Des Moines: \$3,080.00 installed less electrical work

Electrical – Wedeking Electric: \$1,987.33

Final Proposal

Lift - Access: \$46,450.00 + tax \$3,251.50 = \$49,701.50

ADA Door Opener – DH Pace: \$3,080.00 (tax included)

Electrical - Wedeking Electric: \$1,987.22

Total for whole project: \$54, 768.72

Less removal if we remove and dispose: (\$1,000.00)

TOTAL: \$53,768.72

Discussion was held on the project. There were questions on the weight limit (600# - which is the highest weight rating), placement of the lift (where current one is) and using memorial funds that were designated for the ADA updates. Motion was made by Deb McWhirter to proceed with a vote to approve all three aspects of the final proposal for a total of \$53,768.72. Paula Anderson seconded the motion. Motion carried. Kathy Bruns then made a motion to vote by show of hands versus a paper ballot. Jason Shaull seconded the motion. Motion Carried. President Davies asked for a show of hands for in favor. All present raised hand in favor, no opposed. Motion carried for the project.

Linda Thoreson made a motion to adjourn. It was seconded by Danny Bohlen.

Meeting was adjourned at 10:35 am.
