## REPORTS:

Treasurer's Report: November income was \$11,395.96 and November expenses totaled \$13,587.83. Motion by Andrew, second by Amanda to approve the Treasurer's report. All ayes. Motion carried.

Secretary's Report: Motioned by Amanda, second by Jim to approve the November 12, 2025, minutes. All ayes. Motion carried.

Stewardship and Finance: They met in early December and have a 2026 proposed budget that will be presented for council approval to be presented at the annual meeting.

The ADA door has been ordered and will be delivered in the next few weeks. The new bell tower louvers have been delivered and will be replaced in the spring.
